Dear Friends of Keep Pennsylvania Beautiful,

We're excited to share our progress and accomplishments that speak to the commitment we share with our grantors, partners, supporters, and volunteers toward a collective vision of a clean and beautiful Pennsylvania.

In November 2021, we were honored to join the Pennsylvania governor's office, the PA Department of Environmental Protection, PA Department of Transportation, other administration and community members to announce Pennsylvania's first-ever Litter Action Plan. The Litter Action Plan reflects the work of more than 100 stakeholders from state and local government, businesses and the legislature. The goal of the plan is to prevent littering through the development and implementation of a research-based plan of recommended actions that can be used in communities statewide to change littering behavior over time.

In response, PA Fights Dirty: Every Litter Bit Matters media campaign was launched with the goal of educating Pennsylvanians on situational littering, such as leaving trash on the ground next to a full can or in a stadium, and to remind Pennsylvanians that litter of all sizes adds up and creates problems. Both the Litter Action Plan and the statewide media campaign were informed by Keep Pennsylvania Beautiful's comprehensive litter research. The Cost of Littering and Illegal Dumping in Pennsylvania and Pennsylvania Litter Research Study. These found approximately 502.5 million pieces of litter on Pennsylvania's roadways, costing the state and just nine cities upwards of \$80 million annually.

We are honored to work with our state agency partners to implement the Litter Action Plan through education, public awareness and community engagement and improving waste management policies and practices to reduce littering and illegal dumping. Unquestionably, our passionate affiliates and volunteers will be key throughout implementation.

In closing, whether it is providing technical assistance to communities through Illegal Dump Free PA, providing mini-grants to community groups or assisting volunteers wanting to clean up their community, working directly with the people of Pennsylvania is our first line of mission delivery.

We are grateful for your continued support. Thank you for making our collective efforts and accomplishments possible.

EMPOWERING PENNSYLVANIANS

Pick Up Pennsylvania

Since 2004, in partnership with PA Department of Environmental Protection, PA Department of Transportation and Ocean Conservancy's International Coastal Cleanup, Pennsylvania residents have depended on Pick Up Pennsylvania, our community improvement program, for the tools and resources needed to make a difference in their neighborhoods. During Pick Up Pennsylvania, 65,988 people participated in cleanups, beautification, education and recycling events. Over 3.4 million pounds of trash was picked up and disposed of properly and 104,495 trees, flowers and other greens were planted in shared public spaces.



Waterway Stewards

This year, we launched a new Waterway Steward Program with funding from the Department of Environmental Protection's (DEP) Coastal Resources Management. The program's purpose is to engage Pennsylvania water trail users in community science and build long-term stewardship of our water trails while providing



valuable data to tell the story about litter in and along our waterways. During the program's inaugural year, 67 Pennsylvanians committed to integrating stewardship into their recreational waterway activities.



Land Stewards

Through a partnership with PA Department of Environmental Protection, groups and individuals continue to participate in our road and area adoption program. The program not only provides an incentive to keep the places we love clean, it also helps mitigate local cleanup costs by equipping residents with the tools and resources they need to be stewards of their neighborhoods and other shared public spaces. The program is available statewide for municipal roads, parks, neighborhood blocks, greenways, and trails. Keep Pennsylvania Beautiful provides a sign recognizing the volunteers' efforts and partners with the local municipality to provide the sign post, install the sign and provide trash disposal options as needed. Of the close to 300 adoptions, 96 have participated for more than 10 years and 96 for over 20 years.

Healing The Planet Grant Program Highlights

In 2021, we partnered with The GIANT Company to award 42 Healing the planet grants ranging from \$2,500 up to \$25,000, totaling \$532,500, in support of connecting people and families with community green spaces through park improvements, park builds, watershed restoration, recycling infrastructure and related programs, beautification and greening, community gardens, vacant lot restoration, outdoor classrooms and tree plantings. Eligible projects were required to be located in The GIANT Company's operating areas within Pennsylvania, Maryland, Virginia and West Virginia and to be on public land or be for public use and benefit.

Affiliate Training Highlights

All affiliates have access to quarterly trainings and networking opportunities as a way to share ideas and connect with peers across the state with similar programs and roles. This year's training included:

Leave No Trace: The Rotten Truth About Trash

A quest speaker from Leave No Trace joined us for a virtual workshop that provided an overview of the Leave No Trace Seven Principles, with an emphasis on the principle to "dispose of waste properly," that protect the outdoors while minimizing our impacts to the land, soil, vegetation, water, wildlife, cultural resources and other visitors.

Steal This!

Our affiliates were invited to share programs, unique to their affiliate, that can be shared and duplicated by others in the network.

- > Tri-County CleanWays' Executive Director, Jerry Zona, shared the value of offering localized Recycling Fact Sheets to lessen the confusion around recycling and reduce waste and contamination in the recycling stream. He shared how to get started, the cost involved and how to distribute the education resources within the community.
- > Westmoreland CleanWays and Recycling's Program Director, Natalie Reece, shared how their new apiary came to be, the affiliate's unique educational programs, the operation of their recycling drop-off center, including their specialized foam densifier and the coordination of their household hazardous waste drives.

Affiliate Fund Highlights

Our affiliates are integral to their communities. They are local organizations that share resources, information and opportunities for residents,



businesses, other organizations and local governments to address community improvement priorities. This year, we optimized our affiliate structure and process for supporting affiliates across the state. We expanded our staff to provide direct support to our network of affiliates, created a comprehensive training program to encourage connectivity, collaboration and knowledgesharing. We also invested in funding dedicated to local efforts where true change happens.

Some notable projects that were funded by this fund include:

Allegheny CleanWays TriTrashLon –

TriTrashLon was a two-day dumpsite and riverfront cleanup event. Twenty volunteer participants joined Allegheny CleanWays' DumpBusters crew in McKeesport for a dumpsite cleanup, followed by a group bike ride to Clairton for a lunch-and-learn about air pollution in the area. Afterward, the group biked together to a campsite on the Montour Trail. The following morning, the group rode together back to McKeesport for a riverfront cleanup on the Monongahela River with the Tireless Project, accompanied by a speaker to discuss issues

surrounding watershed protection. The volunteers and crew removed over 8,000 pounds of trash and 60 tires from the 10th ward of McKeesport.

Keep Northeastern PA Beautiful Education

Outreach – Buckets and nets to investigate the shoreline of the Susquehanna River, bristled brushes to show the proper way to clean shoes and coloring pages and fun worksheets to help kids identify invasive species were all part of the two educational experiences that focused on non-native, invasive species management in the region. The goal of the events was to educate the community, adults and students alike on sustainable practices and opportunities for involvement.

Tri-County CleanWays Special Collection

Program – Due to rising costs of holding special collections, the affiliate was considering dropping the collection of tires from their recycling program in Butler, Lawrence and Mercer counties. Instead, the affiliate fund allowed them to maintain a reasonable tire disposal fee structure for residents while minimizing the economic impact to the affiliate.



Young Ambassador Program

Through a partnership with PA Department of Transportation, we launched the Young Ambassadors Program and accepted 35 young Pennsylvanians into the program for the 2022-2023 school year. The goals of the Young Ambassadors Program are



to: build community stewardship by inspiring, engaging, and empowering young Pennsylvanians to keep their communities clean and beautiful, and develop civic leaders to champion and advocate for clean and beautiful communities across Pennsylvania. We know the students of today hold the key to a sustainable future. We're excited to work with and guide this group of Young Ambassadors to implement change in their communities and the Commonwealth.

Litter Free School Zone

Nearly 100 schools in Pennsylvania currently participate in our Litter Free School Zone program to keep their school grounds clean and beautiful. This program, offered in partnership with PA Department of Environmental Protection, encourages hands-on activities to teach environmental stewardship and responsibility and is often combined with lessons on how litter affects animals, people, water quality and economics.

PA Fights Dirty

We are excited to work with the Department of Community and Economic Development and our state agency partners to launch the state's new anti-



litter campaign, PA Fights Dirty: Every Litter Bit Matters. The campaign highlights small everyday actions that everyone can do by focusing on litter four inches or less, which makes up the bulk of Pennsylvania litter. The campaign has been years in the making and was developed in response to Pennsylvania's recent Litter Action Plan. The goal of "Every Litter Bit Matters" is to educate Pennsylvanians on situational littering, such as leaving trash on the ground next to a full can or in a stadium, and to remind Pennsylvanians that litter of all sizes adds up and creates problems.

INFRASTRUCTURE MATTERS Rural Transfer Stations Rule Change

Currently, all residents of the Commonwealth do not have convenient and affordable access to waste disposal and recycling. On September 15, 2022, the Department of Environmental Protection Environmental Quality Board updated regulations to establish requirements for the operation of rural transfer facilities. This change was developed to create waste management and recycling opportunities for more citizens and in communities that are currently underserved or without collection infrastructure. By providing convenient and affordable access to waste disposal and recycling services in rural areas, this rule change will help alleviate the mismanagement of residential municipal waste and associated burning or illegal dumping.

Cigarette Litter Prevention Program

In 2022, we partnered with the PA Department of Transportation to implement the Cigarette Litter Prevention Program (CLPP) at 14 state welcome centers. The program will raise awareness to travelers about properly disposing cigarette butts using messaging and marketing campaigns and placing ash receptacles at entrances to rest stop buildings. The effectiveness of the program will be measured by comparing a pre and post program count of littered cigarette butts and other tobacco products.

The cigarette butt waste that is collected through this program is recycled and composted through a partnership with TerraCycle. The various materials that make up a cigarette are separated and processed. The filters are melted into hard plastic that can be remolded to make new industrial products, such as plastic pallets. The residual tobacco and paper are separated out and composted in a specialized process.

This is a continuation of our work throughout the state to reduce the amount of cigarette and tobacco litter. Since 2010, we have implemented the Cigarette Litter Prevention

Program in our state parks and to date, we have worked with 41 of the 121 state parks with an overall combined reduction rate of 64%.

This fiscal year alone, participating facilities provided disposal for 490,480 pounds of trash, a value of \$17,167.







The GIANT Company

Through a continuation of projects initiated by The GIANT Company's Reduced Emissions Program, developed in partnership with PDI Sustainability Solutions, Keep Pennsylvania Beautiful and local affiliates partnered on three mission-aligned employee engagement events in spring 2022.

- > Keep York Beautiful joined 30 volunteers from The GIANT Company who planted approximately 250 trees on four acres of land as a riparian buffer, pulled weeds, spread gravel and cleared brush, making a huge impact at the Horn Farm Center for Agricultural Education.
- > Keep Centre County Beautiful and 20 team members from The GIANT Company combined efforts to refurbish and beautify Centre County Recycling and Refuse Authority's compost demonstration site, adding raised pollinator garden beds, embankment stabilization, juniper shrubs and mulch. A litter sweep of the area resulted in 73 bags of trash and over 700 pieces of recyclables.
- > Keep Harrisburg/Dauphin County Beautiful and their host organization, Tri County Community Action, joined with 16 team members from The GIANT Company to weed planters, which were replenished with fresh flowers, in 19 locations along Market and Derry streets. The volunteers then worked at The Heart of the Community Garden pulling weeds, trimming and mowing, while others completed a litter sweep, collecting 12 bags of trash.


