## **Healing the Planet Grants**

Healing the Planet 2022 was a competitive grant program in support of projects aimed at improving the health and quality of waterways to help protect water resources and improve the overall health of communities. Projects funded included stream health and water quality monitoring activities, marine debris removal, storm water/MS4 education initiatives, lake/pond ecology, watershed education activities, watershed landscape measures, rain gardens, streambank restoration, erosion control, AMD remediation, rain barrels, pollution abatement and source water protection. Eligible applicants and proposed projects were required to be located in The GIANT Company's operating areas within Pennsylvania, Maryland, Virginia and West Virginia and to be on public land or be for public use and benefit.

The GIANT Company and Keep Pennsylvania Beautiful awarded 45 Healing the Planet grants ranging from \$2,500 up to \$10,000, totaling \$300,000. Funding for the grants was provided by customers at GIANT, MARTIN'S and GIANT Heirloom Market stores who rounded up their grocery purchase to the nearest dollar from March through May.

## Renaturalization of the Mountain Creek Buffer at Pine Grove Furnace State Park

Michaux State Forest, Cumberland County, PA

Volunteers cleared vast amounts of woody invasive vegetation including Privet, Japanese Barberry, Multiflora Rose, Bush Honeysuckle, and Asiatic Bittersweet, and replanted with 6 to 16 feet native trees, smaller native tree and shrub seedlings and live stakes, and native herbs. As the new plants establish, they will increasingly promote the ecosystem services of the riparian buffer, shading and cooling the stream, stabilizing the streambank, preventing erosion, slowing runoff, filtering pollutants and excess nutrients, and sequestering carbon. These native plants will also support communities of insects and higher secondary consumers such as fish, amphibians, reptiles, small mammals, and birds. Clearing invasive species has also increased accessibility for visitors.

## A Week in the Codorus Creek: Investigating Factors that Influence Stream Health in Urban vs. Rural Areas

York Academy Upper School, York County, PA

The York Academy 11th grade Diploma Programme students engaged in gathering and interpreting physical, chemical, and biological data at two locations along Codorus Creek to evaluate environmental factors that affect the water. The students brainstormed possible solutions to mitigate negative impacts with the goal of improving stream health in the local urban community. Students, wearing waders, used handheld microscopes to identify microorganisms and microplastics and to remove 200 pounds of debris from the creek. The three week project culminated with the students presenting their findings at an exhibition open to community members.



Our stream health investigation comparing urban and rural influences on physical, chemical, and biological factors was a huge success, boosting the academic and personal growth of the students involved. Additionally, community connections made during the project will help to develop this project in the coming years!

## Innovative Techniques for Community Monitoring of Vernal Pools

Western PA Conservancy, York County, PA

Focusing on restored and unmodified vernal pool habitats, this project expanded and improved wetland monitoring programs at Gifford Pinchot State Park and Kings Gap Environmental Education Center. Staff and 154 volunteers installed 30 hydrological monitoring stations to track water depth and seasonal duration of flooding, and 15 photo stations at pools located near trails, which are used to track seasonal changes in these dynamic wetland habitats.

In addition, the Vernal Pool Phenology Project (VPPP), a regional monitoring effort led by the Ecological Research as Education Network, monitored water levels and water temperature, took photos, and recorded wood frog calls and amphibian egg masses and measured the leaf out stage in trees around the pools. The results will be used to help determine vernal pools selected for future monitoring.

## **Rails to Trails East Bridge Replacement**

Town of Mount Airy, Carroll County, MD

Word spread quickly around town as people learned a new bridge was coming. The Rails-to-Trails nature path in the Town of Mt. Airy follows the original 1830s B&O rail line. When the trail section was constructed several years ago, a small wooden bridge was installed allowing access to the trail from Watkins Park. The bridge was narrow, slippery when wet and was not even with the ground, causing challenges for strollers, wheelchairs, bikes, and pedestrians. The Healing the Planet grant funded the construction of a wider, safer, and more permanent bridge that is accessible to all, repairing the vital link between people and the town's history and culture. Visitors and residents can easily access the trail to exercise, relax in nature and reach downtown shops. With the new bridge completed, the town intends to continue environmental projects and activities such as planting and maintaining native flowers and grasses along the creek and near the bridge, installing an educational sign near the bridge to inform users about the Chesapeake Bay Watershed and how actions in Mt. Airy impact the health of the Bays as well as local waterways.

## Schuylkill River Park Arboretum

Friends of Schuylkill River Park, Philadelphia County, PA

Schuylkill River Park, the largest open green space in southwest Center City, plays a significant role in the daily lives of thousands of Philadelphia residents because of its central location and recreational opportunities it offers. Friends of the Schuylkill River Park wanted to raise awareness and interest in the park's trees that not only add beauty but also offer shade, help mitigate the heat island effect, and provide food and habitat for wildlife by having it certified as an arboretum. The first step was to identify, map and evaluate the health of the park's trees. Hazardous trees were pruned and five dead trees were removed. In addition, over 20 new trees were planted.

The certified level one arboretum designation inspired significant interest from the community. Signage was installed to educate park-users and local school children about the benefits of its trees. Increased awareness of the needs of the park's trees also attracted a significant donor, Center City Residents' Association, which has made a multi-year commitment to fund their care.

## Wildlife Leadership Academy

Wildlife Leadership Academy, Centre County, PA

The mission of the Wildlife Leadership Academy is to engage and empower high school age youth to become Conservation Ambassadors to ensure a sustained wildlife, fisheries and natural resource legacy for future generations. In 2022, 100 youth participants and 20 youth mentors, from 40 counties across the commonwealth as well as one student each from District of Columbia, Maryland, New Jersey, and Virginia were accepted to attend five field schools. This experience begins with training, including attending rigorous summer field schools taught by leading natural resource professionals that focus on wildlife and fisheries conservation, as well as leadership skills development. Through the next year, students equipped with knowledge and skills, give back to their communities through education, service, media engagement, the creative arts and outdoor mentorship. The Academy offers five field schools in total – two are aquatic related, PA Bass (warm water fisheries), and PA Brookies (Brook Trout and freshwater fisheries).

The Academy continues to mentor students and provide opportunities such as check-in video calls, college visit days, and an opportunity to attend professional meetings. From high school to college, Academy support includes college and jobs references, job experience as summer staff for the field schools, and informal career counseling.

## Watershed Cleanup, Trail and Tree Maintenance

9th Street Community Center, Delaware County, PA

The 9th Street Community Center held 35 different events for the Environmental Youth Corps to do watershed and trail cleanups, tree trimming, and general maintenance. The estimated attendance at these events was 260. Students and other community members were engaged to support the park and trail areas and had fun while learning more about the importance of keeping their environment healthy. In the summer months of 2022, students helped with the Garden box project and many families were able to enjoy the abundance of vegetables that were grown. Now that the park and creek are clean, residents are visiting, trees are being planted and tended, and students are using the park during the summer months. Residents with dogs are utilizing the disposal sites.

# Replanting Rouss Spring Hillside with Native Plants

Winchester-Frederick County Convention and Visitors Bureau, Clarke County, VA

The Winchester-Frederick County Convention and Visitors Bureau cleared invasive species and planted over 500 native plants including 34 trees, 91 grasses and sedges and 380 perennials on the historic and ecologically significant Rouss Spring Hillside. Stabilizing plants were strategically placed to reduce hillside degradation and act as a runoff buffer into the spring water source. Native plants were chosen to promote biodiversity, support increased pollination and help mitigate climate change as part of nature-based climate solutions. Replanting was done without chemicals as the spring feeds into Opequon Creek, which drains to the Shenandoah River and Chesapeake Bay. Opequon Creek is also the current water source for the City of Winchester.

Historically, Rouss Spring served as a Native American water source and the City of Winchester's water source for more than 60 years. The site is also the location of the oldest home in Winchester, Abram's Delight, that dates to the mid-1700's.

### Monongahela River Story Map

PA Division of the Izaak Walton League, Fayette County, PA

Using a GoPro camera, the PA Division of the Izaak Walton League, photographed the Monongahela River from Pittsburgh to the Pennsylvania border, and completed 80 percent of the West Virginia portion of the Monongahela River and the Tygart, Cheat and West Fork rivers. The goal is a picture story map of the Monongahela River using 360-degree interactive maps using modern mobile mapping technology from EarthViews and Esri ArcGIS online mapping.

The maps will provide visual insights of the river's shoreline. This platform will play a significant role in conservation, economic, and recreational opportunities. Once the visual and graphic mapping is complete, layers describing conditions will be added such as history and recreational use, water quality and ecosystem type and health. Information will be available for public use.

Lehman Sanctuary continued work on their teaching rain garden system infrastructure, adding erosion control measures, plantings, seed broadcasting, and perimeter fencing, deterring deer encroachment. Naturalists and environmental educator outreach on ecosystem and storm water management was expanded to local schools and community groups. Outreach included students from grades one through twelve, college students and adult groups. In all, 12 educators reached over 300 students. In addition, new storm water education television and outdoor public service announcement broadcasts reached an audience of over 10,000 and hundreds more viewed the numerous social media messaging posts.




