

Community Engagement


The Keep Pennsylvania Beautiful (KPB) team continues to give back to our local community through volunteering.



This year...

- In support of Keep America Beautiful's three-year campaign to clean and green ahead of the nation's 250th anniversary, the theme was: **Join the Greatest American Cleanup: Show us how you keep your community litter free!**
- Winners were honored during a **special awards ceremony at the Pennsylvania State Capitol**. Sixty-nine students, teachers, parents, guardians, and agency representatives attended to celebrate their achievements and show support.
- Winning artwork was on display at the PA State Capitol Build during the month of April.
- Additionally, the Pennsylvania Turnpike Commission displayed winning artwork at service plazas along the turnpike.



Open Your Eyes to Litter Series: Building Young Environmental Stewards

Our Open Your Eyes to Litter series helps build anti-litter habits early, fostering lifelong responsibility and respect for the environment. With funding from the PA Department of Environmental Protection, we continue working with the Eastern Pennsylvania Coalition for Abandoned Mine Reclamation and illustrator Brady Mock to update the series. 
At Afton Elementary in Bucks County, environmental stewardship is woven into the school culture. Through the Young Environmentalists Program, students meet weekly to lead hands-on projects that support their school and community. Each year, students identify litter as a top concern, conducting four school-grounds cleanups, two in fall and two in spring, where they track progress and see the results of their efforts over time. These experiences foster responsibility, confidence, and long-lasting environmental habits. Many students also return to school eager to share that they have independently completed additional litter clean-ups in their own neighborhoods or local parks, demonstrating that these experiences are shaping habits and values beyond the school setting.

Young Ambassadors Class of 2025 The Next Generation of Environmental Stewards

Twenty-six students graduated from our Young Ambassador class of 2025! The Young Ambassador Program, supported by funding from the Pennsylvania Department of Transportation, continues to grow in both reach and impact. Each year, the program empowers more students to become environmental leaders, equipping them with hands-on experiences, professional mentorship, and opportunities to lead real conservation projects in their communities.

Trainings throughout the year brought Young Ambassadors together with representatives from Governor Shapiro's office, PA Department of Environmental Protection, PA Department of Conservation and Natural Resources, PA Department of Transportation, PA Department of Community and Economic Development, Philadelphia Office of Clean and Green Initiatives, Pennsylvania Environmental Council, Keep Texas Beautiful, Keep Virginia Beautiful, and industry leaders from Columbia Gas NiSource Charitable Foundation and Dow, for a series of high-impact learning experiences.

Young Ambassador Spotlight - Noori Choudhary

Since graduating from the Young Ambassador program, Noori has become a key leader at Brinton Run Preserve. She has organized more than 30 restoration events, engaging 150 volunteers, and planting over 1,100 native trees to restore acres of habitat and support the return of species like the Eastern bluebird. As the lead youth coordinator, she designs and runs conservation projects from start to finish, launched a bluebird monitoring initiative, built a data partnership with the North American Land Trust, and transformed volunteers into informed environmental stewards through hands-on education and community collaboration.

Healing the Planet Grants - The GIANT Company

Through a partnership with The GIANT Company, Keep Pennsylvania Beautiful awarded **37 Healing the Planet (HTP) grants, totaling \$119,022**, in support of native tree planting projects across The GIANT Company’s operating area within Pennsylvania. Highlights include:

The **Youth Roots Student-Led Native Tree Restoration** planted 20 native trees across five **Pottsville School District** sites, helping restore the damaged tree canopy and improve local environmental conditions. Twenty-five students led the research, site selection, and planting, gaining hands-on experience in environmental stewardship.

The **Forest Habitat Restoration** revitalized 19 acres at **Jenkins Arboretum & Gardens** by planting 270 native trees and 25 shrubs to rebuild a healthier forest canopy. Sixty-four volunteers gained stewardship experience and a stronger connection to the woodland they help care for. The visible improvements now provide the community with a greener, more resilient landscape.

The **Urban Wetland Tree Planting at Wildwood Park** will expand the tree canopy along heavily used **Harrisburg trails**, strengthening the existing Roadside Beautification Project forested buffer and improving air quality for the many people who use the park and trail system to bike, jog, walk, exercise their dogs, and enjoy the flora and fauna.

Community Greening Grants - Columbia Gas - NiSource Charitable Foundation

Columbia Gas - NiSource Charitable Foundation, provided funding for eight community greening and beautification projects including:

Allegheny CleanWays Dumpbuster Crew, Water Program Crew, and Education programs worked to improve ecosystem health by educating the public and removing illegally dumped materials from land and water. During a three-day cleanup on the Ohio River, a four-person crew and 20 volunteers removed 6,748 pounds of trash.

ClearWater Conservancy planted over 1,000 trees and shrubs as a riparian buffer at Millbrook Marsh, Centre County, improving eroding streambanks and aquatic habitat. This work will have long-lasting benefits to the environment by improving water quality, providing carbon storage, and creating wildlife habitat.

Coatesville 2nd Century Alliance and 28 volunteers planted 48 native shrubs and trees, and over 200 bulbs, at the Coatesville Public Library in Chester County, supporting pollinators and improving stormwater infiltration and soil structure, creating a vibrant, welcoming, and environmentally sustainable public space.

Keep Fayette County Green partnered with Youth Recycling Ambassador, Luke Hamaker to remove 635 tires and 4,760 pounds of trash from a one-mile stretch of Barron Road and 374 tires from Mountain View Road in Dunbar Township.



PA CleanWays of Venango County enhanced and expanded the pollinator garden at the Venango Conservation District by planting 46 native perennials and 19 shrubs with the help of 40 students and staff from the Venango Technology Centers' Natural Resource Program.

Tri-County CleanWays partnered with the South Side Community Garden Improvement Project in Lawrence County on major improvements at the Southside Community Garden, which serves approximately 60 families. Fifteen volunteers from the local community, Holistic Industries, and DON

Enterprises rebuilt and winterized garden beds, repaired signage, and more.

Tri-County CleanWays also hosted Composting and Waste-Reduction Workshops in Butler County, distributing 65 compost bins.

To be completed in spring 2026: **Westmoreland Cleanways and Recycling** will expand their community pollinator garden to include a pavilion and picnic tables that will be used for education events and public use.

America250PA - In partnership with America250PA, we awarded \$30,000 to ten recipients through the **2025 National Pennsylvania Day Mini Grants** program. The grants support community projects that engage volunteers and improve public spaces. Grants of up to \$4,000 were available to existing America250PA partners, helping local organizations deliver projects that strengthen communities across the Commonwealth.



Keep America Beautiful - With funding from Keep America Beautiful, and in partnership with the Erie-Western Pennsylvania Port Authority, we implemented the **Cigarette Litter Prevention and Recycling** program at local marinas in Erie who share our commitment to keep PA waterways free of tobacco-related litter. The program uses education, infrastructure, and pocket ashtray distribution to keep shorelines clean and free of tobacco related litter. Butts collected in receptacles are shipped to Terracycle for new lives as industrial products and compost.

Building Capacity

Keep Pennsylvania Beautiful offers statewide networking and training opportunities for affiliates to learn, grow, and collaborate with peers. Trainings covered an overview of Illegal Dump Free PA, Pick Up Pennsylvania, how to leverage education programs, and more.

Community Stewardship Summit

The two-day event began with a walking tour of Scranton, highlighting year-round greening efforts, pollinator gardens, revitalized community spaces, and public art. Mayor Paige Cagnetti later hosted an evening reception and declaration signing supporting the Great American Cleanup.

Keynote speaker Kristine Zeiglar, CEO and Co-founder of Planet Women, urged attendees to rethink traditional leadership and adopt narratives that address inequality and environmental harm. She was joined by three Young Ambassador alumni who shared their own

community leadership experiences.

Breakout sessions focused on waterway litter and marine debris infrastructure, volunteer litter-control program audits, and the educational and economic tools that can strengthen communities.

Affiliate Fund: Fueling Growth

Affiliate Fund Highlights



Coatesville Citywide Cleanup & Beautification

Coatesville residents mobilized for a citywide cleanup and beautification effort. Grant funding provided rakes, brooms, dustpans, grabbers, gloves, and trash bags. More than 50 volunteers collected approximately 170 bags of litter, along with bulk debris and tires, significantly improving the appearance of city streets and public spaces. Volunteers also planted flowers and greenery in downtown planters, adding color and community pride. The event received strong support from local businesses, city departments, and officials, enhancing visibility and momentum for future cleanup initiatives.

Expanding Community Capacity Through SKIP's Cleanup Kit Initiative

Schuylkill Keep It Pretty (SKIP) created and distributed 30 cleanup kits for libraries, businesses, and municipalities, making it easier and more accessible for community members to organize local cleanups. The kits were put to great use during SKIP's Spring Clean event. Thanks to the collective effort of more than 100 volunteers, over 200 bags of litter were removed from communities across the county. SKIP's efforts were strengthened through partnerships with the Schuylkill Conservation District, Mahanoy Chamber, Pottsville Rotary, Pottsville Youth Summit Club, Shenandoah Chamber of Commerce, Schuylkill Area Community Foundation, and the PA Department of Transportation.

Keep Delco Beautiful – Public Launch Event

The public launch of Keep Delco Beautiful brought residents together for a park cleanup and beautification while introducing them to the many community groups participating in the initiative's advisory board. The event also encouraged attendees to sign up for future volunteer opportunities. The launch brought together 11 community organizations and 96 participants, including volunteers, partner groups, and staff. They removed more than 60 bags of trash, and hazardous and bulky items including needles, mattresses, an armchair, motor oil, and significant amounts of plastic and tobacco waste.

PICK UP PENNSYLVANIA

Pick Up Pennsylvania, the state's largest community improvement program, is held in partnership with PA Department of Environmental Protection and PA Department of Transportation. Additional support is provided by PA Waste Industries Association and the Ocean Conservancy.

Teamwork in Action: Cook MyoSite's Earth Day Park Cleanup

With planning support, promotional materials, and free supplies provided by Keep Pennsylvania Beautiful, Cook MyoSite's MYO-BRAVE Employee Resource Group and Community Engagement Team hosted the company's first Earth Day clean-up at Regional Industrial Development Corporation Park in O'Hara Township, Allegheny County.

Employees collected more than 20 bags of litter from around the company's facilities, strengthening teamwork, community connection, and time outdoors. On-site volunteers also took part in "Clean-Up Bingo," with treats and raffle prizes, while remote employees joined the national #152PickUpChallenge.

Employee feedback reflected both surprise at the amount of litter in the park and appreciation for the opportunity to make a visible difference.

Cultivating Community Pride Along the Conestoga River

The Conestoga River Club is now in its third year of a unique and growing partnership with the Omega Fi Si fraternity at Franklin & Marshall College. Established in 2022, the collaboration has built a meaningful tradition of stewardship, community pride, and long-term care for the local environment. Omega Fi Si deepened its involvement by incorporating community service into its Rush-to-Brotherhood process, making civic engagement a core value for new members. Though student-group partnerships can be challenging due to turnover, Todd Roy, Director of Programs at The Conestoga River Club, notes that intentionally nurturing relationships creates lasting impact.

Since the partnership began, the annual Earth Day cleanup, registered as a Pick Up Pennsylvania event, has removed more than 130,000 pounds of trash from the Conestoga River watershed.

Thanks to our ongoing partnership with the Pennsylvania Waste Industries Association, participants in our **Pick Up Pennsylvania** program received free or reduced-cost trash disposal for registered cleanups from April 1 through April 30.

Volunteer Spotlight: Razvan Dominic Ionescu, Founder of One Beautiful Planet

This year, Keep Pennsylvania Beautiful is honored to spotlight One Beautiful Planet and its founder, Razvan Dominic Ionescu, whose passion for environmental stewardship has significantly strengthened our collective impact across the Commonwealth. Founded in 2023 by Razvan Ionescu, One Beautiful Planet's mission is to inspire, perform, and support restorative environmental action. Fueled by a genuine desire to leave every space better than he found it, Razvan's environmental journey is personal, rooted in his upbringing in Bucharest, Romania, and summers spent exploring the Carpathian Mountains and the Black Sea coast. One Beautiful Planet now leads and participates in volunteer cleanups across Bucks, Montgomery, and Philadelphia counties. To date, the group has carried out 78 cleanups, gathering approximately 2,530 pounds of litter. We are grateful for Razvan's support and friendship.

Community Engagement

Land Steward Program

Keep Pennsylvania Beautiful's Land Steward Program empowers residents and local organizations to adopt and care for public spaces, strengthening community engagement and promoting long-term environmental stewardship.

Building on this foundation, **Keep Chester City Beautiful** created a **Block Caption Program**, an initiative designed to further enhance neighborhood involvement and promote cleaner, safer streets. Block Captains serve as a vital link between residents, City Hall, and Keep Pennsylvania Beautiful, coordinating communication, supporting local projects, and helping to schedule and promote community cleanup events. So far, eight city streets have been adopted.



Keep Pennsylvania Beautiful
currently has over 665 land, water,
and school stewards combined.

Similarly, **Keep Norristown Beautiful and the Municipality of Norristown** collaborated with Keep Pennsylvania Beautiful to launch, promote, and facilitate the Keep Pennsylvania Beautiful Land Stewards program for the City of Norristown. Their goal is to see every street adopted by local families, scout groups, civic organizations, faith-based communities, and businesses. To date, over 30 streets in Norristown have been adopted. These efforts, combined with larger cleanups organized by the Municipality, continue to enhance the appearance of Norristown while fostering community pride and long-term environmental stewardship.






